POOL REGULATIONS

- ✓ Pool Rental Permits will be issued during designated time periods
- ✓ Applications will be accepted no more than **90 days and no less than 14 days** in advance of the use date.
- ✓ Pool rentals include the use of the pool with lifeguards; the applicant will be responsible for checking clothing and valuables. Only persons authorized by the applicant will be admitted into the building.
- ✓ No admission or spectator charges may be collected at the pool, and no concession may be sold without written approval of the Recreation Services Department.
- ✓ A portion of deposit will be **non-refundable**. The non-refundable portion will go towards the Pattullo Swim Center Maintenance Fund. The **Refundable** Portion will be returned to applicant pending condition of building and rules followed
- ✓ In case of cancellation, please notify the Pattullo Swim Center Front Office as soon as possible. Refund requests made **30 days in advance** will receive a full refund less a \$7 surcharge. Refund requests made **14-29 days in advance** will receive a 50% refund of all fees plus a \$7 surcharge will be applied. Refund requests made **less than 14 days in advance** will NOT be refunded.
- ✓ Representatives of the applicant will be responsible for supervision and enforcement of all rules and regulations of the Recreation Services Department pertaining to use of the facility.
- ✓ Change of additional hours and slide usage must be made prior to **14 days** of the rental date.
- ✓ Building must be **cleared and empty** at the conclusion of duration time to receive refundable deposit.
- ✓ No alcohol, drugs, or tobacco allowed anywhere on the premises at the Pattullo Swim Center.

FACILITY RULES

- ✓ No one is allowed in the pool unless a lifeguard is on duty.
 - ✓ Everyone must shower before entering the pool.
 - ✓ All babies **MUST** be wearing a swim diaper or "Little Swimmers" **AND** a bathing suit OVER the swim diaper to enter the pool.
 - ✓ Cutoffs, body suits, t-shirts, and regular diapers are prohibited.
 - ✓ Food and drink are permitted in designated areas only; no glass allowed.
 - ✓ Non-swimmers must stay in shallow end or learning pool.
 - ✓ Children under 48 inches tall must be accompanied by an adult when using large pool.
 - ✓ Children under 42 inches tall must be accompanied by an adult when using the learning pool.
 - ✓ Back dives and flips are not allowed.
 - ✓ Fighting, rough housing, chicken fights and piggy back rides are prohibited.
 - ✓ Sitting or hanging on lanes is not permitted.
 - ✓ No open sores or bandages allowed.
 - ✓ Suntan oils and lotions are not permitted.
 - ✓ Swimmers must clear the pool at lifeguards' request.
