- ✓ **Please note: special rules and conditions may apply for different events.**
- ✓ Vendor locations are not held in advance.
- ✓ The space provided varies in size per event. **If you need more space, please notify us in advance before the date you are registered for.** Additional Fee may be required.
- ✓ When setting up your booth space please be respectful of your neighbors space as well.
- ✓ Vendors are required to set up their own booth. City Staff will NOT be able to assist.
- ✓ Vendors are requested **not to leave until fifteen minutes after the event ends.** Vendors leaving early will not be invited to future events.

Additional food vendor rules:

- ✓ **Food vendors must secure a permit and conform to the Monterey County Health Department regulations.** The Health Department will be strictly enforcing their rules by visiting each booth weekly. Information and requirements can be obtained by calling the Health Department at 831-647-7654.
- ✓ To avoid duplication of food sales, food sold must be approved in advance, on a first come, first serve basis. Please only sell foods that you have received permission to sell. Food vendors may sell non-alcoholic beverages.
- ✓ Depending on the event, food vendors might have to accept food vouchers from performers to be provided a meal and a drink at no cost. The City of Seaside will not be refunding the cost for the meal provided in exchange for this voucher.
